Protecting Tupperware's Trademark in China

Overview

his is a criminal raid action against an infringer who produced and sold counterfeit products in large quantities.

The infringer in this case, Che, manufactured counterfeit Tupperware goods and sold them without obtaining legal authorization from the trademark right holder, Dart Industries, Inc. Che had been hiding in Guangzhou for many years, and after our investigations, we successfully located the warehouse of the infringer Che.

On October 29, 2021, we cooperated with Hengfeng County Public Security Bureau to conduct a criminal raid action against the infringer Che and his warehouse. The police successfully arrested the infringer and seized on the spot about 60,000 pieces of counterfeit products and over 100,000 pieces of various accessories. This criminal raid action is one of the largest raid actions we have successfully conducted for our client Tupperware.

It is worth mentioning that the infringing warehouse is located in Guangzhou City, which is also the location of the client's affiliated company in China. As a result, the criminal raid action was very significant in that we were able to help the client remove obstacles from their doorstep and greatly increase confidence in the sales force of their company.


Difficulties

However, the address of the infringer's warehouse and the identity of the infringer were difficult to determine, and the infringer was very vigilant so the difficulty of criminal raid action is high. In addition, the number of seized counterfeit goods was huge, and the transfer of counterfeit goods and preservation of evidence required a lot of manpower and material resources. Lastly, it is difficult to track the source of the molds.

Strategies and Significance

Chang Tsi & Partners carefully reviewed the case, seeking for effective and economic legal solutions. Firstly, through various means of investigation, we successfully located the infringer's warehouse and confirmed the identity of the infringer. Secondly, cooperating with the public security, we has smoothly promoted the progress of the criminal raid action. Third, five large trucks were urgently arranged for transport from Guangzhou to Hengfeng County. Lastly, we traced the mold manufacturer through the mold quotation.

Through this criminal raid action, we successfully helped our client to take down a large warehouse storing counterfeit goods. The number of counterfeit products involved in this case is one of the highest we dealt with. This criminal raid played a great deterrent effect on the local chain of counterfeit sales and was able to reduce the numbers of counterfeit goods in the market at the root and safeguard the legal rights of our client.

Trademark Registration in Macau

1. A Brief Introduction of our Macao Team

2. Guide of Trademark Registration in Macau

Besides Hong Kong, the famous policy "One country, two systems" has been adopting in the Macao Special Administrative Region of China. A registration in China Mainland will not grant you any protection in Macau. As Macau is an important role in Greater China, this article will guide you to have a knowledge of trademark registration in Macau.

A. Sources of law

The principal source of law and regulation relating to trade marks in Macau is the Industrial Property Code, adopted by Decree-Law Number 97/99/M, effective from 13 December 1999. As a supplement, the following 3 Chief Executive's Notices also applies, where appropriate:

International Classification of Goods and Services for the Purpose of the Registration of Marks (Nice Classification) 9th Edition -Notice of Chief Executive No. 10/2009;

Approving the table of fees due for the acts provided for in the Industrial Property Code -Notice of Chief Executive No. 10/2009; Regarding the models of certificates that prove Industrial Property rights and forms for applications for granting Industrial Property rights - Notice of Chief Executive No. 10/2009.

B. Competent Administration

Trade mark registration in Macau is separate from mainland China. The Economic and Technological Development Bureau (DSEDT) is a public department of the Macao Special Administrative Region (MSAR) responsible for trademark examining and granting. The related website is:

At present, Macau is not the member of Madrid system. As such, if you want trade mark protection in Macau, you will need to seek a local IP agent for assistance.

C. Filing procedure and documentation

The requirements and related documents for the filing of a trademark application in Macao are as follows:

- the applicant's full name, nationality, address or place of business;
- a representation of the mark;
- the list of goods and services;
- a certified copy of the home application, if a priority is claimed;
- and an original copy of power of attorney signed by the legal representative and notarized by a notary public.

Less than most countries in the world, the period of publication for opposition in Macau only takes 2 months. If no opposition or objection is raised against the trademark application, you may expect the registration certificate within 6 to 8 months after date of filing. The duration of registration of a Macau trademark is seven years from the application date and is renewable for further seven-year periods. A renewal application shall be filed prior to six months before the mark expires.
