### **Representative Cases**

• Represented DFJ DragonFund (Shanghai) Equity Investment Management Co., Ltd. filed the trademark infringement and unfair competition lawsuit against 6 defendants. In 2019, Beijing IP Court rendered the favorable judgment to DFJ and order the defendants to stop trademark infringement and unfair competition, publish the clarification statement to eliminate the effects, change their enterprise names, and compensate DFJ DragonFund damages of CNY 3 Million and reasonable cost around

CNY 470,000 jointly.

- In the trademark refusal case, win a favorable judgment for the client IFIXIT. The applied mark and the cited mark are similar, and our negotiation for the letter of consent with the owner of the cited mark went not smooth. Through careful searches, Shawn located that the owner has been canceled its AIC registration, with the new findings and related case laws searches, Shawn successfully convinced the judge to believe the registration of the applied mark will not bring confusion among the public with the cited mark. In the end, the judge approved the applied mark's registration.
- Win 2 trademark invalidation cases for client ITW. Successfully convinced the court to hold that ITW's prior use of Buildex on fastener(nails) has certain fame in the fields and ITW's registration for Buildex in Class 7 are similar to Hangzhou Chuangyi's forestalled registrations for "Buildex and Design" and "Builder and Design" in Class 6. Clean up the obstacles for ITW's application for BUILDEX on fastener(nails), the goods of ITW's core interest.
